Assalam-o-alaikum,

I am pleased to inform you that, you have been provisionally selected by the Coaching and Guidance Cell(C&GC) of the West Bengal State Haj Committee (as per enclosed list) to undergo rigorous, painstaking but highly significant coaching for WBCS Examination that is conducted by the Public Service Commission, West Bengal.

You are directed to report to the Executive Officer, West Bengal State Haj Committee (WBSHC)on 7<sup>th</sup> floor Haj Tower, Kaikhali, VIP Road, Kolkata 700052 within 15 days.

Each candidate has to deposit **Rs. 5000/- (Rupees Five Thousand only)** in favour of Haj House Welfare Fund by demand draft or online payment as security deposit (refundable) at the time of admission. Admission will not be granted without payment of security deposit.

A copy of the Hostel rules & regulations and an application form for admission to hostel are enclosed herewith.

You must bring the following original documents to be submitted in the office of WBSHC with one attested copy each thereof:-

I. Mark Sheets /Certificates from Standard X onwards.II. Birth Certificate.III. OBC Certificate(if any).IV. Two Passport size photographs.V. Notary Affidavit of Undertaking

Please note carefully that all the original mark sheets and other testimonials will be returned to you only on the completion of the entire coaching programme, the duration of which is 11 (Eleven) months. However, if such testimonials are required by you before the end of the programme for appearing in any examinations or interviews etc., then you can make a written request for the same but acceptance of such a request shall be considered on a case to case basis and shall be solely at the discretion of the WBSHC authorities.

Please bring with you the writing materials like pen, pencil, eraser, sharpener, foot scale, one dozen long note books of 200 pages each and two medium size locks for your lockers. You must also bring a small general dictionary &a dictionary on your subject, the books of the optional subject which you want to choose for the WBCS exam.

Normally, once you join the Haj Tower by 15/05/2022, you will not be allowed to leave it till you finish your Examination in 2022.

The personal belongings viz. mobile phones, cameras, laptops & other electronic items and electrical appliances, gold and diamond jewelry and costly items will be at the risk and responsibility of the candidate.

You are instructed to join the C & GC at Kolkata within 15 days, otherwise admission in C&GC will be cancelled and you shall be replaced by students in the waiting list.

## **GUIDELINES**

### (RULES & REGULATIONS)

#### WBCS Coaching & Guidance Cell (C & GC)

- 1. Students have to attend all classes strictly and have to strictly appear in all the tests conducted by the Centre. In case of absence from classes/tests or unsatisfactory performance in tests, the students can be expelled from C&GC.
- 2. Admission to C&GC is provisional. It would be confirmed after satisfactory performance in the tests conducted in the initial two months.
- 3. The Hostel accommodation in Haj Tower is allotted to candidates registered at the C&GC for the Civil Services Examinations only.
- 4. Every Hosteller shall maintain and observe:
  - a. Strict discipline, peaceful atmosphere and decent behavior in the Hostel. Shouting misbehaving talking loudly and/ or causing disturbance in any manner whatsoever to other Hosteller shall not be tolerated.
  - b. The Hostel rooms and lobby should be kept neat and clean. The Hosteller should report to the Office if it is not clean.
  - c. There should be a sense of friendliness and co-operative spirit among all.
- 5. Instances of indiscipline and/ or indecent behavior with any of the staff or faculty of WBSHC shall be severely dealt with and appropriate disciplinary action will be taken against the guilty student including cancellation of admission and summarily expulsion from the programme as well as forfeiture of full security deposit money.
- 6. In case a Hosteller is required to remain out of the Hostel for one or more days on account of any exigencies, he/she shall personally submit the requisite LEAVE APPLICATION to the Director/ Executive Officer, stating the proper reason and obtain prior written permission before leaving the Haj Tower. Otherwise appropriate disciplinary action will be taken against him/her all leave application must be submitted at last three day before leave date.
- 7. Continuous absence from the Hostel for a period of three days or more without obtaining prior permission shall result in revocation of admission from the C&GC.
- 8. No visitor, guest, relative or any other outsider shall be allowed to enter into the premises of the Hostel without prior permission. If any Hosteller is found to have taken his/her guest or visitor in any part of the Hostel premises and/ or in any of the rooms of the Hostel, immediate disciplinary action will be taken against him.
- 9. Every Hosteller shall have in his/her possession his/her Identity Card and shall produce whenever called upon to do so by any of the Hostel/WBSHC Authorities including the Watchman man/Security at the Haj Tower premises.
- 10. Every Hosteller shall take personal care of all his/her goods and belongings. The Administration of the Hostel/WBSHC shall under no circumstances, be responsible, for any pilferage, theft, loss and /or damage of any of the articles, books and /or any other goods or belongings of any of the Hostellers in and /or from any part of the Hostel premises.
- 11. Electricity in the Hostel shall be used in the most economical and careful manner. The lights, fans, geysers, coolers and others electrical installations and appliances shall be switched of every time when not in use. No Hosteller can keep and/or bring from outside into the Hostel any electrical or electronic appliances, gadgets or devices of any type. Electric stove (Sigri), water heater, tape recorder, radio/transistor, mobile, portable TV and / or electronic gadgets or articles are strictly prohibited.

- 12. Water taps shall always be kept closed when not in use and water shall be used economically and wastage should be strictly avoided.
- 13. Complete silence must be maintained and proper and decent behavior observed while using and/ or passing through the Hostel premises.
- 14. The Hostel/ WBSHC Administration, has right to remove and expel any Hosteller at any time without assigning any reason. On such expulsion the said Hosteller shall forthwith leave and quite the Hostel.
- 15. No Hosteller shall have any right or be entitled to convene, hold, address and/ or attend any meeting of the Hostellers for any purpose whatsoever in the Hostel premises without prior written permission in that behalf from the Administration well in advance. The Administration shall have the right to refuse or grant such permission without assigning any reason whatsoever.
- 16. If a Hosteller for any reason whatsoever, discontinues his/her coaching or joins any other course or job he/she shall forthwith leave and quite the Hostel. Actual charges for staying and fooding charges to be deposited to WBSHC by the Hosteller for this particular case.
- 17. In the event of it being discovered that a Hosteller has obtained admission in the Hostel on false representation and/ or by resorting to forging and/ or producing a false document, he/she shall be immediately expelled from the Hostel and his/her security deposit shall stand forfeited.
- 18. Every Hosteller shall quietly and peacefully have to quite the Hostel along with all his/her goods and belongings immediately on or before the date on which his/her admission expires. In the event of his/her failure to do so all his/her goods and belongings will be removed and his/her deposit will be forfeited.
- 19. Any Hosteller whose admission is for any reason cancelled and/ or revoked and/ or has been expelled from the Hostel shall be prevented from having any access to the Hostel premises thereafter.
- 20. No Hosteller shall have any right to question and/ or challenge any decision of Hostel/WBSHC Administration in respect of any matter whatsoever pertaining to the Hostel.
- 21. All Administrations are for the period specifically mentioned in the application.
- 22. All Hostellers must take their meals compulsorily in the Hostel Mess. Eating in the Hostel Mess shall be a part of Hostel discipline and no one will be allowed to eat the food in the room or any place other than the Mess.
- 23. All Hostellers are required to attend all the lectures, meetings, group discussions, Hostel competitions, etc., whenever arranged in the Hostel compulsorily. All male Hostellers are expected to attend Namaz congregation (Jamat) in the prayer hall on the 6<sup>th</sup> floor of Haj Tower.
- 24. In case of any grievance the aggrieved hosteller should approach the Director/Executive Officer, WBSHC.
- 25. All Hostellers should also note that they stay in the Hostel at their own wish, willingness and risk. The Hostel/WBSHC Administration will not be responsible for any of their personal problems or mishaps of any kind.
- 26. Smoking, Chewing pan, Supari, gutka, tobacco, spitting in the Hostel premises is strictly prohibited. Offenders will be dealt with severely by the Administration.
- 27. No ragging or mischief of any kind will be tolerated. There is severe punishment on such an offence.
- 28. The Hosteller shall follow all the rules & regulations in force and those which may be enforced from time to time in future.
- 29. In case of misbehavior/indiscipline/breach or violation of any rules & regulations, the Hosteller will be removed from the Hostel and his/her deposit will be forfeited.
- 30. The hosteller should not enter the room of female students and vice versa.
- 31. Female students are expected to be in Hijab/Scarf.
- 32. The Administration of the Hostel/WBSHC reserves the right at any time, without assigning any reason, to change, alter, add, amend or modify any of the rules & regulations and it shall be binding upon the Hosteller, who shall observe and comply with the same.
- 33. A student admitted should be in the Haj Tower for all 24 hours of a day, 7 days a week till the end of the programme, the duration of which is 11 (Eleven) months.
